

PRIVACY DATA POLICY

Beautiful Connection Therapies respect your right to privacy and aim to comply with our obligations under the data protection legislation currently in force in Ireland and the EU. The purpose of this Privacy Policy is to outline how we deal with:

Personal and Non-Personal data.

We may collect data from our service users and customers who visit the beautifulconnectiontherapies.ie Website and/or communicate with beautifulconnectiontherapies.ie directly.

Beautifulconnectiontherapies.ie does not purchase Personal Data from third parties.

If you are not happy with this Privacy Policy you should not use the beautifulconnectiontherapies.ie Website nor its services.

Types of Information Collected

Beautifulconnectiontherapies.ie generally retains the following information:

“Personal Data”

This is data that identifies you or can be used to identify or contact you and may include your name, email address, physical address and telephone number. Such information is only collected from you if you voluntarily submit it to us (for example by submitting your billing information during a purchase).

Personal Data

Beautifulconnectiontherapies.ie will process Personal Data you provide to us for the following purposes:

- To confirm /receive a booking made by you
- To process purchases of Gift Vouchers;
- To process payments from or to you.
- To send you information you have requested;
- To inform you about changes to our service, our agreement with you or website that we believe will be of interest to you;

“Non-Personal Data”

Like most websites, Beautifulconnectiontherapies.ie may gather statistical and other analytical information collected on an aggregate basis of all visitors to our website. This Non-Personal Data comprises information that cannot be used to identify or contact you, such as demographic information regarding, for example browser types, time spent on our site and other anonymous statistical data involving the use of our beautifulconnectiontherapies.ie website.

Cookies

Beautifulconnectiontherapies.ie does not use “cookie” technology.

Disclosure of Information to Third Parties

Beautifulconnectiontherapies.ie will only provide Personal Data to third parties, where we have been given your consent to do so or to fulfil a specific service you have requested from our service providers.

For example, we share your Personal Data (such as name, contact information, basic relevant information) with the provider of a service offered by beautifulconnectiontherapies.ie on behalf of a third party.

Security, storage and transfer of information

We follow strict security procedures to ensure that your personal information is not damaged, destroyed, or disclosed to a third party without your permission (unless they are providing services as outlined in the ‘Disclosure of Information to Third Parties’ section above) and to prevent unauthorised access to it. The computers that store the information are kept in a secure facility with restricted physical access with the use of secure firewalls and other measures to restrict electronic access. If we are working with third parties, we require them to have in place similar measures to protect your information. No data transmission over the Internet can be guaranteed to be 100% secure and any transmission is at your own risk. You acknowledge that we are not responsible for any intercepted information sent via the internet and you hereby release us from any and all claims arising out of and related to the use of intercepted information in any unauthorised manner.

Updating, Verifying and Deleting Personal Data

You may inform us of any changes in your Personal Data, and in accordance with our obligations under the Data Protection Legislation Beautifulconnectiontherapies.ie will update or delete your Personal Data accordingly. You may contact us to request the details of what Personal Data Beautifulconnectiontherapies.ie hold on you or to have your Personal Data updated, amended or removed from our database.
